Terms of Payment

Payment is due in full prior to removal from place of death for hospital and coroner cases, and before cremation for residential and nursing home cases. We accept VISA, Discover, MasterCard, American Express, Check and Cash.

Direct Cremation

Includes the basic services of a funeral director and staff, the collection of the decedent from a hospital or coroner's office (in Orange, Riverside, San Bernardino and San Diego Counties), sheltering the decedent in refrigeration, and alternative container, transport to crematory, crematory fee, disposition permit fee, Department of Consumer Affairs fee, plastic utility urn, and the packaging and delivery or mailing of cremated remains by USPS within our service area. If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The containers we provide are fiberboard.

Basic Services of Funeral Director and Staff

The fee includes coordinating all cremation arrangements, registering the death certificate in the county where the death occurred, obtaining the health department disposition permit, and obtaining certified copies of the death certificate on your behalf.
